#### Minimum Qualifications:

- 1) An earned MA/MS in fire protection administration and/or engineering, public administration, disaster planning and/or administration, organizational leadership or a closely-related field from an accredited institution (or equivalent) is required;
- 2) Demonstrated experience as a fire service and/or emergency management services professional;
- 3) Demonstrated teaching experience at the college level in a related field or equivalent, and;
- 4) Ability to demonstrate a commitment to working effectively with faculty, staff, and students in a multicultural/multiethnic urban campus environment with a substantial population of first-generation students.

#### Preferred Qualifications:

- 1) Professional affiliation with fire service/EMS industry partners;
- 2) Experience advising and mentoring students;
- 3) Experience engaging with fire service/EMS academic programs, and;
- 4) Evidence of previous management and/or leadership experience.

#### Duties:

The candidate will be responsible for teaching undergraduate classes in the Fire Protection Administration and Technology program, advising students on academic and career preparation issues, developing and implementing curriculum and related assessment procedures, being productive in scholarly activities, and participating in service to the Department, College, and University. The candidate will be expected to be active in relevant professional organizations and foster relationships with public sector organizations such as LA City Fire Department and LA Country Fire Department, among others.

The primary professional responsibilities of instructional faculty members are: teaching, research, scholarship and/or creative activity, and service to the University, profession and to the community. These responsibilities generally include: advising students, participation in campus and system-wide committees, maintaining office hours, working collaboratively and productively with colleagues, and participation in traditional academic functions.

The successful candidate will be committed to the academic success of all of our students and to an environment that acknowledges, encourages, and celebrates diversity and differences. To this end, the successful candidate will work effectively, respectfully, and collaboratively in diverse, multicultural, and inclusive settings.
