- Review proposed updates to building and fire codes, regulations, standards and bylaws and prepare comments that support or oppose these updates
  after evaluating their effects on fire safety and protection
- Provide technical expertise and information to other Fire Services areas on equipment, materials, procedures, and regulatory requirements through research and analysis that support the decision making process
- Liaise with Fire Investigations area to provide technical support
- Perform other responsibilities as assigned by the Fire Chief
